# Dimension reduction for the full Navier-StokesFourier system 

Jan Březina, Ondřej Kreml and Václav Mácha


#### Abstract

It is well known that the full Navier-Stokes-Fourier system does not possess a strong solution in three dimensions which causes problems in applications. However, when modeling the flow of a fluid in a thin long pipe, the influence of the cross section can be neglected and the flow is basically one-dimensional. This allows us to deal with strong solutions which are more convenient for numerical computations. The goal of this paper is to provide a rigorous justification of this approach. Namely, we prove that any suitable weak solution to the three-dimensional NSF system tends to a strong solution to the one-dimensional system as the thickness of the pipe tends to zero.

## 1. Introduction

As introduced in [8, Chapter 1], governing equations for a flow of a general compressible viscous heat conducting fluid in a domain of $\mathbb{R}^{3} \mathrm{read}$ as

\partial_{t}(\rho \mathbf{u})+\operatorname{div}_{x}(\rho \mathbf{u} \otimes \mathbf{u})+\nabla_{x} p(\rho, \theta)-\operatorname{div}_{x} \mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right) & =0,  \tag{1.2}\\
\partial_{t}(\rho s(\rho, \theta))+\operatorname{div}_{x}(\rho s(\rho, \theta) \mathbf{u})+\operatorname{div}_{x}\left(\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right)}{\theta}\right) & =\sigma, \tag{1.3}
\end{align*}
$$

where $(\rho, \mathbf{u}, \theta)$ stand for the unknown fluid mass density, the velocity field and the temperature respectively, $p$ is the pressure, $s$ is the entropy, $\mathbf{q}$ is the heat flux, $\sigma$ is the entropy production rate and $\mathbb{S}$ represents the stress tensor.

[^0]We consider a family of shrinking domains $\Omega_{\varepsilon}$ of the form

$$
\Omega_{\varepsilon}=Q_{\varepsilon} \times(0,1), \quad Q_{\varepsilon}=\varepsilon Q
$$

where $Q$ is an open rectangular domain in $\mathbb{R}^{2}$ and $\varepsilon>0$. Under suitable conditions on the initial data it is natural to expect that weak solutions $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$ of (1.1)-(1.3) on $\Omega_{\varepsilon}$ tend, as $\varepsilon \rightarrow 0$, to a classical solution $(\tilde{\rho}, \tilde{u}, \tilde{\theta})$ of the one-dimensional system

& \partial_{t}(\tilde{\rho} \tilde{u})+\partial_{y}\left(\tilde{\rho} \tilde{u}^{2}\right)+\partial_{y} p(\tilde{\rho}, \tilde{\theta})-\partial_{y}\left[\tilde{S}\left(\tilde{\theta}, \partial_{y} \tilde{u}\right)\right]=0  \tag{1.5}\\
& \partial_{t}(\tilde{\rho} s(\tilde{\rho}, \tilde{\theta}))+\partial_{y}(\tilde{\rho} s(\tilde{\rho}, \tilde{\theta}) \tilde{u})+\partial_{y}\left(\frac{q\left(\tilde{\theta}, \partial_{y} \tilde{\theta}\right)}{\tilde{\theta}}\right)= \\
& \frac{1}{\tilde{\theta}}\left(\tilde{S}\left(\tilde{\theta}, \partial_{y} \tilde{u}\right) \partial_{y} \tilde{u}-\frac{q\left(\tilde{\theta}, \partial_{y} \tilde{\theta}\right) \partial_{y} \tilde{\theta}}{\tilde{\theta}}\right) \tag{1.6}
\end{align*}
$$

where $\tilde{S}\left(\tilde{\theta}, \partial_{y} \tilde{u}\right)$ is naturally related to the three-dimensional stress tensor $\mathbb{S}$ and similarly $q$ to the heat flux vector $\mathbf{q}$, see (2.19)-(2.21). Hereinafter we use the notation $x=\left(x_{h}, y\right) \in \mathbb{R}^{3}, x_{h}=\left(x_{1}, x_{2}\right) \in \mathbb{R}^{2}, y=x_{3} \in \mathbb{R}$ and denote the derivative in $x_{3}$ by $\partial_{y}$. In this paper we give a rigorous justification of the convergence $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right) \rightarrow(\tilde{\rho},(0,0, \tilde{u}), \tilde{\theta})$.

As far as we know, the limit passage for heat conductive fluids has not yet been rigorously investigated and there is only a handful of results on related problems. Since incompressibility in one dimension does not allow any movement, such limit makes a little sense for 1D incompressible flows. However, dimension reduction to 2D-planar flows was examined in [9], [12], [13], [14] - see also references given therein. The case of a compressible barotropic fluid was studied by Vodák [17] and later by Bella et. al. [2].

The paper is organized as follows. In Section 2 we introduce detailed description of our problem. In Section 3 we present the concepts of a weak and a classical solution for 3D and 1D system, respectively, and discuss their existence. The main result is stated in Section 4. Section 5 contains preliminary calculations which are later used in Sections 6 and 7 in order to establish the proof of the main theorem from Section 4.

## 2. Setting of the problem

### 2.1. Structural hypothesis for the 3D problem

For given $\varepsilon>0$ the system (1.1)-(1.3) on $\Omega_{\varepsilon}$ is complemented by the initial conditions

\rho_{\varepsilon}(0, \cdot)=\rho_{0, \varepsilon}, \quad \rho_{\varepsilon} \mathbf{u}_{\varepsilon}(0, \cdot)=(\rho \mathbf{u})_{0, \varepsilon} \text { and } \theta_{\varepsilon}(0, \cdot)=\theta_{0, \varepsilon}
$$

such that the integral averages over $Q_{\varepsilon}$ converge weakly (with respect to $y$ ) in $L^{1}(0,1)$ to some limit as $\varepsilon \rightarrow 0$. For the precise conditions see the statement of Theorem 4.1.

We suppose that the viscous stress tensor $\mathbb{S}$ is a linear function of the velocity gradient and therefore described by the Newton's law

\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right)=\mu(\theta)\left(\nabla_{x} \mathbf{u}+\nabla_{x}^{T} \mathbf{u}-\frac{2}{3} \operatorname{div}_{x} \mathbf{u} \mathbb{I}\right)+\eta(\theta) \operatorname{div}_{x} \mathbf{u} \mathbb{I}, \tag{2.1}
\end{equation*}
$$

with the shear viscosity coefficient $\mu(\theta)>0$ and the bulk viscosity coefficient $\eta(\theta) \geq 0$ satisfying

$$

\mu(\theta)=\mu_{0}+\mu_{1} \theta, \quad \eta(\theta)=\eta_{0}+\eta_{1} \theta, \quad \mu_{0}, \mu_{1}>0, \quad \eta_{0}, \eta_{1} \geq 0 \tag{2.2}
\end{equation*}

The heat flux $\mathbf{q}$ satisfies the Fourier's law

$$
\begin{equation*}
\mathbf{q}\left(\theta, \nabla_{x} \theta\right)=-\kappa(\theta) \nabla_{x} \theta \tag{2.3}
\end{equation*}
$$

where we assume the following form of $\kappa(\theta)$

\kappa(\theta)=\kappa_{0}+\kappa_{2} \theta^{2}+\kappa_{3} \theta^{3}, \quad \kappa_{i}>0, i=0,2,3 \tag{2.4}
\end{equation*}

The system of equations (1.1)-(1.3) with the constitutive relations (2.1) and (2.3) is called the Navier-Stokes-Fourier system.

Equations (1.1)-(1.3) are supplemented with the conservative boundary condition

$$

and the complete slip boundary conditions

$$
\begin{equation*}
\left.\mathbf{u} \cdot \mathbf{n}\right|_{\partial \Omega_{\varepsilon}}=0, \quad\left[\mathbb{S}\left(\nabla_{x} \mathbf{u}\right) \cdot \mathbf{n}\right] \times\left.\mathbf{n}\right|_{\partial \Omega_{\varepsilon}}=0 \tag{2.6}
\end{equation*}
$$

where the symbol $\mathbf{n}$ denotes the outer normal vector. It is worth pointing out that the complete slip boundary conditions are suitable for a dimensionreduction as the no-slip boundary conditions yield only a trivial solution in the asymptotic limit $\varepsilon \rightarrow 0$.

The concept of a weak solution to the Navier-Stokes-Fourier system based on the Second law of thermodynamics was introduced in [5]. The weak solutions satisfy the field equations (1.1)-(1.3) in the sense of distributions where the entropy production rate $\sigma$ is a non-negative measure,

\sigma \geq \frac{1}{\theta}\left(\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right): \nabla_{x} \mathbf{u}-\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right) \nabla_{x} \theta}{\theta}\right) \tag{2.7}
\end{equation*}
$$

In order to compensate for the lack of information resulting from the inequality sign in (2.7) the system is supplemented with the total energy balance,

$$
\frac{\partial}{\partial t} \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho|\mathbf{u}|^{2}+\rho e(\rho, \theta)\right) d x=0
$$

where $e=e(\rho, \theta)$ is the (specific) internal energy. Under these circumstances it can be shown (see [8, Chapter 3]) that any sufficiently smooth weak solution of (1.1)-(1.3) satisfies the standard relation

\sigma=\frac{1}{\theta}\left(\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right): \nabla_{x} \mathbf{u}-\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right) \nabla_{x} \theta}{\theta}\right) .

The proof of our main theorem is based on the method of the relative entropy (see [3], [4], [15]), represented by the quantity

where $H^{\Theta}(\rho, \theta)$ is the thermodynamic potential called the ballistic free energy

$$
H^{\Theta}(\rho, \theta)=\rho e(\rho, \theta)-\Theta \rho s(\rho, \theta)
$$

introduced by Gibbs and discussed more recently by Ericksen [6].
We assume that the thermodynamic functions $p, e$ and $s$ are interrelated through the Gibbs' equation

$$
\begin{equation*}
\theta D s(\rho, \theta)=D e(\rho, \theta)+p(\rho, \theta) D\left(\frac{1}{\rho}\right) \tag{2.9}
\end{equation*}
$$

The subsequent analysis leans essentially on the thermodynamic stability of the fluid expressed through

\frac{\partial p(\rho, \theta)}{\partial \rho}>0, \quad \frac{\partial e(\rho, \theta)}{\partial \theta}>0 \text { for all } \rho, \theta>0 \tag{2.10}
\end{equation*}

Motivated by the existence theory developed in [8, Chapter 3] we assume that the pressure $p=p(\rho, \theta)$ can be written in the form

p(\rho, \theta)=\theta^{\frac{5}{2}} P\left(\frac{\rho}{\theta^{\frac{3}{2}}}\right)+\frac{a}{3} \theta^{4}, \quad a>0, \tag{2.11}

where

P \in C^{1}[0, \infty), P(0)=0, P^{\prime}(Z)>0 \text { for all } Z \geq 0 \tag{2.12}
\end{equation*}
$$

In agreement with Gibbs' relation (2.9), the specific internal energy can be taken as

$$
\begin{equation*}
e(\rho, \theta)=\frac{3}{2} \frac{\theta^{\frac{5}{2}}}{\rho} P\left(\frac{\rho}{\theta^{\frac{3}{2}}}\right)+a \frac{\theta^{4}}{\rho} \tag{2.13}
\end{equation*}
$$

Furthermore, by virtue of the second inequality in the thermodynamic stability hypotheses (2.10), we have

In particular, (2.14) implies that the function $Z \mapsto \frac{P(Z)}{Z^{\frac{5}{3}}}$ is decreasing and we suppose that

Finally, the formula for the (specific) entropy reads from the Gibbs' equation (2.9) as

\end{equation*}

where, in accordance with the Third law of thermodynamics,

S^{\prime}(Z)=-\frac{3}{2} \frac{\frac{5}{3} P(Z)-Z P^{\prime}(Z)}{Z^{2}}<0 \tag{2.17}
\end{equation*}

### 2.2. Structural hypothesis for the 1 D problem

Since we are interested in smooth solutions of the 1D equations, we complement the system of equations (1.4)-(1.6) with the initial conditions

$$
\begin{equation*}
\tilde{\rho}(0, \cdot)=\tilde{\rho}_{0}, \tilde{u}(0, \cdot)=\tilde{u}_{0}, \tilde{\theta}(0, \cdot)=\tilde{\theta}_{0}, \tag{2.18}
\end{equation*}

with $\tilde{\rho}_{0} \geq c>0, \tilde{\theta}_{0} \geq c>0$ and $\tilde{u}_{0}$ being smooth functions.
The form of the stress tensor $\mathbb{S}$ and the heat flux $\mathbf{q}$ naturally yields their one-dimensional counterparts, namely we expect that in the limit we recover

with the viscosity coefficients

\nu_{i}=\frac{4}{3} \mu_{i}+\eta_{i}, \quad i=0,1, \tag{2.20}
\end{equation*}
$$

and

$$
\begin{equation*}
q\left(\tilde{\theta}, \partial_{y} \tilde{\theta}\right)=-\kappa(\tilde{\theta}) \partial_{y} \tilde{\theta} \tag{2.21}
\end{equation*}
$$

## 3. Concepts of solutions

### 3.1. Weak solutions to the 3 D -system

Let $T>0$ and $\Omega \subset \mathbb{R}^{3}$ be a bounded Lipschitz domain. We say that a triple $(\rho, \mathbf{u}, \theta)$ is a weak solution to the Navier-Stokes-Fourier system (1.1)-(1.3) with (2.1)-(2.7) in $(0, T) \times \Omega$ emanating from the initial data
$\rho(0, \cdot)=\rho_{0}, \quad \rho \mathbf{u}(0, \cdot)=(\rho \mathbf{u})_{0}, \quad \rho s(\rho, \theta)(0, \cdot)=\rho_{0} s\left(\rho_{0}, \theta_{0}\right), \rho_{0} \geq 0, \theta_{0}>0$, if:

- the density and the absolute temperature satisfy $\rho(t, x) \geq 0, \theta(t, x)>$ 0 for almost all $(t, x) \in(0, T) \times \Omega, \rho \in C_{\text {weak }}\left([0, T] ; L^{\frac{5}{3}}(\Omega)\right), \rho \mathbf{u} \in$ $C_{\text {weak }}\left([0, T] ; L^{\frac{5}{4}}\left(\Omega ; \mathbb{R}^{3}\right)\right), \theta \in L^{\infty}\left(0, T ; L^{4}(\Omega)\right) \cap L^{2}\left(0, T ; W^{1,2}(\Omega)\right)$ and $\mathbf{u} \in L^{2}\left(0, T ; W^{1,2}\left(\Omega ; \mathbb{R}^{3}\right)\right),\left.\mathbf{u} \cdot \mathbf{n}\right|_{\partial \Omega}=0 ;$
- equation (1.1) is replaced by a family of integral identities

$$
\int_{\Omega} \rho(\tau, \cdot) \varphi(\tau, \cdot) d x-\int_{\Omega} \rho_{0} \varphi(0, \cdot) d x=\int_{0}^{\tau} \int_{\Omega}\left(\rho \partial_{t} \varphi+\rho \mathbf{u} \cdot \nabla_{x} \varphi\right) d x d t
$$

for any $\varphi \in C^{1}([0, T] \times \bar{\Omega})$ and any $\tau \in[0, T]$;

- the momentum equation (1.2) is satisfied in the sense of distributions, specifically,

\qquad \int_{\Omega} \rho \mathbf{u}(\tau, \cdot) \varphi(\tau, \cdot) d x-\int_{\Omega}(\rho \mathbf{u})_{0} \varphi(0, \cdot) d x \\
=\int_{0}^{\tau} \int_{\Omega}\left(\rho \mathbf{u} \partial_{t} \varphi+\rho \mathbf{u} \otimes \mathbf{u}: \nabla_{x} \varphi+p(\rho, \theta) \operatorname{div}_{x} \varphi-\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right): \nabla_{x} \varphi\right) d x d t \\
\quad \text { for any } \varphi \in C^{1}\left([0, T] \times \bar{\Omega} ; \mathbb{R}^{3}\right),\left.\varphi \cdot \mathbf{n}\right|_{\partial \Omega}=0 \text { and any } \tau \in[0, T]
\end{gathered}
$$

- the entropy balance (1.3), (2.7) is replaced by a family of integral inequalities

\begin{gathered}
\int_{\Omega} \rho_{0} s\left(\rho_{0}, \theta_{0}\right) \varphi(0, \cdot) d x-\int_{\Omega} \rho s(\rho, \theta)(\tau, \cdot) \varphi(\tau, \cdot) d x \\
+\int_{0}^{\tau} \int_{\Omega} \frac{1}{\theta}\left(\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right): \nabla_{x} \mathbf{u}-\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right) \cdot \nabla_{x} \theta}{\theta}\right) \varphi d x d t \\
\leq-\int_{0}^{\tau} \int_{\Omega}\left(\rho s(\rho, \theta) \partial_{t} \varphi+\rho s(\rho, \theta) \mathbf{u} \cdot \nabla_{x} \varphi+\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right) \cdot \nabla_{x} \varphi}{\theta}\right) d x d t
\end{gathered}
$$

for any $\varphi \in C^{1}([0, T] \times \bar{\Omega}), \varphi \geq 0$ and almost all $\tau \in[0, T]$;

- the total energy is conserved

$$
\int_{\Omega}\left(\frac{1}{2} \rho|\mathbf{u}|^{2}+\rho e(\rho, \theta)\right)(\tau, \cdot) d x=\int_{\Omega}\left(\frac{1}{2 \rho_{0}}\left|(\rho \mathbf{u})_{0}\right|^{2}+\rho_{0} e\left(\rho_{0}, \theta_{0}\right)\right) d x
$$

for almost all $\tau \in[0, T]$.
The existence of global-in-time weak solutions to the three dimensional Navier-Stokes-Fourier system was established in [8, Theorem 3.1]. It reads as follows.

Theorem 3.1. Let $\Omega \subset \mathbb{R}^{3}$ be a bounded domain of class $C^{2, \nu}$, $\nu \in(0,1)$. Assume that $\rho_{0} \in L^{5 / 3}(\Omega), \int_{\Omega} \rho_{0}=M_{0}>0 ;(\rho \mathbf{u})_{0} \in L^{1}(\Omega),(\rho \mathbf{u})_{0}=0$ almost everywhere on the set $\left\{x \in \Omega, \rho_{0}(x)=0\right\} ; \theta_{0}>0$ a.e. in $\Omega$ is such that $\rho_{0} s\left(\rho_{0}, \theta_{0}\right) \in L^{1}(\Omega)$ and the initial energy of the system satisfies

$$
\int_{\Omega}\left(\frac{1}{2 \rho_{0}}\left|(\rho \mathbf{u})_{0}\right|^{2}+\rho_{0} e\left(\rho_{0}, \theta_{0}\right)\right) d x<\infty
$$

Assume that the structural hypotheses (2.1)-(2.4), (2.7), (2.9)-(2.17) hold. Then for any $T>0$ the Navier-Stokes-Fourier system admits a weak solution $(\rho, \mathbf{u}, \theta)$ on $(0, T) \times \Omega$ in the sense specified above.

Moreover, the authors also proved that every weak solution satisfies the total dissipation balance [8, Equation (2.51)], i.e.,

$$
\begin{align*}
\int_{\Omega}\left(\frac{1}{2} \rho|\mathbf{u}|^{2}+H^{\bar{\theta}}(\rho, \theta)\right)(\tau) d x+ & \bar{\theta} \sigma[[0, \tau] \times \bar{\Omega}] \\
& =\int_{\Omega}\left(\frac{1}{2} \rho_{0}\left|\mathbf{u}_{0}\right|^{2}+H^{\bar{\theta}}\left(\rho_{0}, \theta_{0}\right)\right) d x \tag{3.1}
\end{align*}

for almost all $\tau \in[0, T]$ and for every positive constant $\bar{\theta}$.
Remark 3.2. It may seem that Theorem 3.1 is not suitable for our problem since the domain under consideration is of the form $(a, b) \times(c, d) \times(0,1)$ and hence not of class $C^{2, \nu}$. We overcome this issue by the following consideration. The smoothness of the domain is used in the proof of the existence of weak solutions to ensure the smoothness of Galerkin approximations. In our case we may use the special structure of the spatial domain together with the boundary conditions to extend any solution from $\Omega$ appropriately (as an even or an odd function) to create a solution with periodic boundary conditions on a larger box where no restrictions on the smoothness of the boundary are necessary.

### 3.2. Classical solutions to the 1 D -system

As $\varepsilon \rightarrow 0$ we observe that $\Omega_{\varepsilon} \rightarrow(0,1)$. Moreover, we expect the solutions $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$ of (1.1)-(1.3) on $\Omega_{\varepsilon}$ to converge to a classical solution $(\tilde{\rho}, \tilde{u}, \tilde{\theta})$ of (1.4)-(1.6). The boundary conditions (2.5) and (2.6) naturally lead to the no-slip boundary conditions for the velocity and the heat flux, i.e.,

\tilde{u}(\cdot, 0)=\tilde{u}(\cdot, 1)=0, \quad q\left(\tilde{\theta}, \partial_{y} \tilde{\theta}\right)(\cdot, 0)=q\left(\tilde{\theta}, \partial_{y} \tilde{\theta}\right)(\cdot, 1)=0 . \tag{3.2}
\end{equation*}
$$

There has been published a lot of papers about the one-dimensional Navier-Stokes-Fourier system (1.4)-(1.6) with the no-slip boundary conditions. We refer the reader to [1], [10] and [16] where the existence of solutions was provided under more restrictive assumptions on the pressure, viscosity, energy, etc. However, as far as we know, the global in time existence result for the system in its full generality has not been proven yet. Nevertheless, the local in time existence for any smooth initial data or global in time existence for small data can be expected to hold from the classical results on the topic. Since the existence of a classical one-dimensional solution is not a goal of this paper, we simply assume its existence without any proof. Let $T>0$. We assume that there exists a trio

of smooth functions that is the solution to (1.4)-(1.6) and (3.2) on $[0, T] \times(0,1)$ satisfying

with the initial conditions (2.18).

## 4. Main Result

The main result of this paper reads as follows.
Theorem 4.1. Let $Q \subset \mathbb{R}^{2}$ be an open rectangular domain and let $\Omega_{\varepsilon}=$ $\varepsilon Q \times(0,1)$ for $\varepsilon>0$. Suppose that the structural hypotheses (2.1)-(2.4) and (2.7) for the viscous stress tensor $\mathbb{S}$ and the heat flux $\mathbf{q}$ are satisfied together with (2.9)-(2.17) for the thermodynamic functions $p$, $e$ and $s$.

Assume that the initial data $\left(\rho_{0, \varepsilon},(\rho \mathbf{u})_{0, \varepsilon}, \theta_{0, \varepsilon}\right)$ satisfy all the assumptions of Theorem 3.1 on domains $\Omega_{\varepsilon}$ and denote $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$ the corresponding sequence of weak solutions to the 3D Navier-Stokes-Fourier system on $(0, T) \times \Omega_{\varepsilon}$ emanating from the initial data $\left(\rho_{0, \varepsilon},(\rho \mathbf{u})_{0, \varepsilon}, \theta_{0, \varepsilon}\right)$.

Let $\left(\tilde{\rho}_{0}, \tilde{u}_{0}, \tilde{\theta}_{0}\right)$ be smooth functions such that there exists the classical solution $(\tilde{\rho}, \tilde{u}, \tilde{\theta})$ to the $1 D$ Navier-Stokes-Fourier system on $(0, T) \times(0,1)$ emanating from $\left(\tilde{\rho}_{0}, \tilde{u}_{0}, \tilde{\theta}_{0}\right)$. Define $\tilde{\mathbf{u}}_{0}=\left[0,0, \tilde{u}_{0}\right]$ and $\tilde{\mathbf{u}}=[0,0, \tilde{u}]$.

Let moreover

& \frac{1}{\left|Q_{\varepsilon}\right|} \int_{Q_{\varepsilon}} \rho_{0, \varepsilon} s\left(\rho_{\varepsilon, 0}, \theta_{\varepsilon, 0}\right) d x_{h} \rightarrow \tilde{\rho}_{0} s\left(\tilde{\rho}_{0}, \tilde{\theta}_{0}\right)
\end{align*}
$$

weakly in $L^{1}(0,1)$ and let

& \frac{1}{\left|Q_{\varepsilon}\right|} \int_{\Omega_{\varepsilon}}\left[\frac{1}{2 \rho_{0, \varepsilon}}\left|(\rho \mathbf{u})_{0, \varepsilon}\right|^{2}+\rho_{\varepsilon, 0} e\left(\rho_{\varepsilon, 0}, \theta_{\varepsilon, 0}\right)\right] d x \\
& \rightarrow \int_{0}^{1}\left[\frac{1}{2} \tilde{\rho}_{0}\left|\tilde{u}_{0}\right|^{2}+\tilde{\rho}_{0} e\left(\tilde{\rho}_{0}, \tilde{\theta}_{0}\right)\right] d y \tag{4.2}
\end{align*}

Then

& \operatorname{esssup}_{t \in(0, T)} \frac{1}{\left|Q_{\varepsilon}\right|}\left\|\theta_{\varepsilon}-\tilde{\theta}\right\|_{L^{2}\left(\Omega_{\varepsilon}\right)}^{2} \rightarrow 0
\end{aligned}
$$

and

\frac{1}{\left|Q_{\varepsilon}\right|}\left\|\mathbf{u}_{\varepsilon}-\tilde{\mathbf{u}}\right\|_{L^{r}\left((0, T) \times \Omega_{\varepsilon}\right)}^{r} \rightarrow 0

for every $r \in[1,2)$ as $\varepsilon \rightarrow 0$.
Remark 4.2. Our result can be viewed as an extension of the dimension reduction for the barotropic Navier-Stokes system achieved in [2] to the full Navier-Stokes-Fourier system. The basic strategy of using the relative entropy inequality is the same. However, the presence of the temperature raises new obstacles.

In elasticity theory, the analysis of dimension reduction problems depends on the use of Korn's inequality which controls the gradient of velocity by its symmetric part, i.e.,

There are two problems that arise with respect to above inequality. Firstly, validity even for a fixed $\varepsilon>0$ requires certain restrictions on the shape of the cross-section $Q$. Secondly, even "properly" shaped $Q$ might not stop the constant $c(\varepsilon)$ from blowing up as $\varepsilon \rightarrow 0$.

In [2] authors obtain their result for a regular planar domain $Q$ since they avoid the use of Korn's inequality by exploring the structural stability of the family of solutions of the barotropic Navier-Stokes system. In our case, the approach of [2] is disrupted by the temperature.

Therefore our result leans on the validity of stronger Korn's like inequality appropriate for compressible fluids, namely, we use

To get that we assume that $Q$ is an open rectangular domain in $\mathbb{R}^{2}$, i.e., $Q$ can be written as

## 5. Preliminary calculations

In this section we introduce the estimates which will be used repeatedly in the subsequent calculations. Hereinafter, we assume that $(\tilde{\rho}, \tilde{u}, \tilde{\theta})$ and $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$ are a classical and a weak solution to the respective problem satisfying the assumptions introduced in Theorem 4.1. For clarity, we omit the suffix $\varepsilon$ where no confusion occurs and we write $(\rho, \mathbf{u}, \theta)$ instead of $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$.

Following [8, Chapters 4,5] we introduce essential and residual components based on $\rho$ and $\theta$. To begin, we choose positive constants $\underline{\rho}, \bar{\rho}, \underline{\theta}, \bar{\theta}$ fulfilling

According to Lemma 5.1 in [8] there exists a constant $c>0$ such that

It is worth pointing out that $c$ is independent of $\varepsilon$.
Each measurable function $h$ can be written as

### 5.1. Estimates on $\rho$ and $\theta$

We immediately see from (5.1) that

\end{equation*}

for $s \geq 2$. We show that similar estimates hold also for the residual parts. Firstly,

Now we can estimate the residual parts. We have for $1 \leq q \leq 4$ that

\leq c \int_{\Omega_{\varepsilon}}\left|[\theta]_{\text {res }}\right|^{4} d x+c \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta})
\end{gathered}
$$

Thus

where $1 \leq q \leq 4$. Combining (5.2) and (5.3) we obtain

\leq c \int_{\Omega_{\varepsilon}}\left|[\rho]_{r e s}\right|^{\frac{5}{3}} d x+c \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x .

### 5.2. Korn and Poincaré inequalities

Although both inequalities are very well known, we need the estimates which are independent of $\varepsilon$. Note that this goal cannot be reached by a simple rescaling argument as the domain shrinks only in two dimensions. For more details see Remark 4.2.

For clarity, in this section we prefer the notation $x_{3}$ and $\partial_{x_{3}}$ instead of $y$ and $\partial_{y}$.

Lemma 5.1. Let $\Omega \subset \mathbb{R}^{3}$ be a rectangular domain, i.e., $\Omega=\left(a_{1}, b_{1}\right) \times\left(a_{2}, b_{2}\right) \times$ $\left(a_{3}, b_{3}\right)$ and $\mathbf{u} \in W^{1,2}\left(\Omega, \mathbb{R}^{3}\right)$ be such that $\mathbf{u} \cdot \mathbf{n}=0$ on $\partial \Omega$. Then

\left\|\nabla_{x} \mathbf{u}\right\|_{L^{2}(\Omega)}^{2} \leq \int_{\Omega}\left(\nabla_{x} \mathbf{u}+\nabla_{x}^{T} \mathbf{u}-\frac{2}{3} \operatorname{div}_{x} \mathbf{u} \mathbb{I}\right): \nabla_{x} \mathbf{u} d x .
\end{gathered}

Proof. Since smooth functions are dense in $W^{1,2}\left(\Omega, \mathbb{R}^{3}\right)$, we prove the lemma only for $\mathbf{u} \in C^{2}(\Omega)$. Denote $\mathbf{u}=\left[u^{1}, u^{2}, u^{3}\right]$. We split $\partial \Omega$ into three parts as follows:

\partial_{x_{1}} u^{3}+\partial_{x_{3}} u^{1} & \partial_{x_{2}} u^{3}+\partial_{x_{3}} u^{2} & 2 \partial_{x_{3}} u^{3}
\end{array}\right)
$$

we calculate

& +4\left[\partial_{x_{2}} u^{1} \partial_{x_{1}} u^{2}+\partial_{x_{3}} u^{1} \partial_{x_{1}} u^{3}+\partial_{x_{3}} u^{2} \partial_{x_{2}} u^{3}\right]
\end{aligned}
$$

We integrate by parts to modify the last terms.
First, we integrate by parts in $x_{2}$,

& \quad+4 \int_{\Omega}\left[\partial_{x_{1}} u^{1} \partial_{x_{2}} u^{2}+\partial_{x_{1}} u^{1} \partial_{x_{3}} u^{3}+\partial_{x_{2}} u^{2} \partial_{x_{3}} u^{3}\right] d x
\end{aligned}

$$

we get that

Thus the first inequality is proven. The second inequality follows easily since

## 6. Relative entropy balance

Recall that we omit the index $\varepsilon$ for the functions $\left(\rho_{\varepsilon}, \mathbf{u}_{\varepsilon}, \theta_{\varepsilon}\right)$ and simply write $(\rho, \mathbf{u}, \theta)$ instead. Following the calculations in [7, Section 3] we obtain for each $\varepsilon>0$ the following relative entropy inequality satisfied by any weak solution $(\rho, \mathbf{u}, \theta)$ to the Navier-Stokes-Fourier system on $\Omega_{\varepsilon}$ and any trio $(r, \mathbf{U}, \Theta)$ of smooth functions, $r$ and $\Theta$ bounded below away from zero in $[0, T] \times \Omega_{\varepsilon}$ and $\left.\mathbf{U} \cdot \mathbf{n}\right|_{\partial \Omega_{\varepsilon}}=0$.

\frac{1}{\left|Q_{\varepsilon}\right|} \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho|\mathbf{u}-\mathbf{U}|^{2}+\mathcal{E}(\rho, \theta \mid r, \Theta)\right)(\tau, \cdot) d x \\
+\frac{1}{\left|Q_{\varepsilon}\right|} \int_{0}^{\tau} \int_{\Omega \varepsilon} \frac{\Theta}{\theta}\left(\mathbb{S}\left(\theta, \nabla_{x} \mathbf{u}\right): \nabla_{x} \mathbf{u}-\frac{\mathbf{q}\left(\theta, \nabla_{x} \theta\right) \cdot \nabla_{x} \theta}{\theta}\right) d x d t \\

for almost all $\tau \in[0, T]$, where $\mathcal{E}$ was introduced in (2.8).

\left(\int_{\Omega_{\varepsilon}}\left(|\rho \log \rho|_{\text {res }}\right)^{\frac{4}{3}} d x\right)^{\frac{3}{4}} \leq c\left(\int_{\Omega_{\varepsilon}}\left(\rho^{\frac{4}{3}}+\rho^{\frac{5}{3}}\right) d x\right)^{\frac{3}{4}} \\
\leq\left(\frac{1}{\left|Q_{\varepsilon}\right|} \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x\right)^{\frac{3}{4}}\left|Q_{\varepsilon}\right|^{\frac{3}{4}}
\end{gathered}
$$

From (3.1) and (4.1),(4.2) we deduce that

\leq \frac{1}{\left|Q_{\varepsilon}\right|}\left\|\partial_{y}\left(\tilde{u}-u^{3}\right)\right\|_{L^{1}\left(\Omega_{\varepsilon}\right)} \leq \frac{1}{\left|Q_{\varepsilon}\right|^{\frac{1}{2}}}\left\|\partial_{y}\left(\tilde{u}-u^{3}\right)\right\|_{L^{2}\left(\Omega_{\varepsilon}\right)} .

\end{aligned}

Summarizing the calculations above we get

& \leq c\left|Q_{\varepsilon}\right|^{\frac{1}{4}}\|\nabla \mathbf{u}\|_{L^{2}\left(\Omega_{\varepsilon}\right)}\left(\int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x\right)^{\frac{1}{2}} \\
& \leq \varepsilon\|\nabla \mathbf{u}\|_{L^{2}\left(\Omega_{\varepsilon}\right)}^{2}+c \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x
\end{aligned}
$$

where we used the result of Lemma 5.2.
We conclude that

& \quad+K(\delta, \cdot) \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho\left|u^{3}-\tilde{u}\right|^{2}+\mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta})\right) d x \tag{6.6}
\end{align*}

for any $\delta>0$. Here and hereafter, $K(\delta, \cdot)$ is a generic constant depending on $\delta, \tilde{\rho}, \tilde{u}, \tilde{\theta}, \underline{\rho}, \underline{\theta}$ through its respective norms. It is independent of $\varepsilon$.

Step 3 Using (1.4) and (1.5) we get

+\int_{\Omega_{\varepsilon}}\left(\tilde{u}-u^{3}\right)\left(\partial_{y}\left[\left(\nu_{0}+\nu_{1} \tilde{\theta}\right) \partial_{y} \tilde{u}\right]-\partial_{y} p(\tilde{\rho}, \tilde{\theta})\right) d x \tag{6.7}
\end{gather*}

Due to the regularity of $(\tilde{u}, \tilde{\rho}, \tilde{\theta})$ it follows that

To estimate $\int_{\Omega_{\varepsilon}}\left|(\rho-\tilde{\rho})\left(\tilde{u}-u^{3}\right)\right| d x$ we introduce the following proposition.
Proposition 6.1. There exists $c>0$ independent of $\rho$ and $\theta$ such that

As far as $\partial_{\rho} \mathcal{F}(r) \leq-c<0$ for $r \in\left(0, \frac{3}{2} \underline{\rho}\right)$, we have

\leq \delta\left\|\tilde{u}-u^{3}\right\|_{L^{2}\left(\Omega_{\varepsilon}\right)}^{2}+K(\delta, \cdot) \int_{\{\rho<\underline{\rho}\}}|\rho-\tilde{\rho}| d x \\
\leq \delta\left\|\tilde{u}-u^{3}\right\|_{L^{2}\left(\Omega_{\varepsilon}\right)}^{2}+K(\delta, \cdot) \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x
\end{gathered}

for any $\delta>0$ and

\leq & \int_{\Omega_{\varepsilon}} \rho\left|\tilde{u}-u^{3}\right|^{2}+K(\cdot) \int_{\{\rho>\bar{\rho}\}} \rho d x \leq \int_{\Omega_{\varepsilon}} \rho\left|\tilde{u}-u^{3}\right|^{2} d x+K(\cdot) \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x

The second integral on the right-hand side of (6.7) is handled by integration by parts as

+\int_{\Omega_{\varepsilon}} \tilde{\rho}[s(\rho, \theta)-s(\tilde{\rho}, \tilde{\theta})]_{\text {ess }}\left(\partial_{t} \tilde{\theta}+\tilde{u} \partial_{y} \tilde{\theta}\right) d x
\end{gathered}

where with the help of the Taylor-Lagrange formula and (5.2),

\leq\left(\sup _{(\rho, \theta) \in[\underline{\rho}, \bar{\rho}] \times[\theta, \bar{\theta}]}\left|\partial_{\rho} s(\rho, \theta)\right|+\sup _{(\rho, \theta) \in[\underline{\rho}, \bar{\rho}] \times[\underline{\theta}, \bar{\theta}]}\left|\partial_{\theta} s(\rho, \theta)\right|\right)\left\|\partial_{t} \tilde{\theta}+\tilde{u} \partial_{y} \tilde{\theta}\right\|_{L^{\infty}(0,1)} \\
\times \int_{\Omega_{\varepsilon}}\left|[\rho-\tilde{\rho}]_{\text {ess }}\right|\left(\left|[\rho-\tilde{\rho}]_{\text {ess }}\right|+\left|[\theta-\tilde{\theta}]_{\text {ess }}\right|\right) d x \leq K(\cdot) \int_{\Omega_{\varepsilon}} \mathcal{E}(\rho, \theta \mid \tilde{\rho}, \tilde{\theta}) d x . \tag{6.10}

-\int_{\Omega_{\varepsilon}} \tilde{\rho}\left[\partial_{\rho} s(\tilde{\rho}, \tilde{\theta})(\rho-\tilde{\rho})+\partial_{\theta} s(\tilde{\rho}, \tilde{\theta})(\theta-\tilde{\theta})\right]_{\text {res }}\left(\partial_{t} \tilde{\theta}+\tilde{u} \partial_{y} \tilde{\theta}\right) d x \\
+\int_{\Omega_{\varepsilon}} \tilde{\rho}\left(\partial_{\rho} s(\tilde{\rho}, \tilde{\theta})(\rho-\tilde{\rho})+\partial_{\theta} s(\tilde{\rho}, \tilde{\theta})(\theta-\tilde{\theta})\right)\left(\partial_{t} \tilde{\theta}+\tilde{u} \partial_{y} \tilde{\theta}\right) d x

where the first integral on the right-hand side can be estimated using the Taylor-Lagrange formula of the second order and (5.2) (similarly to (6.10)) and the second integral on the right-hand side can be estimated by (5.3) and (5.5).

## 7. Dissipative terms

The goal of this section is to show that the "dissipative" terms on the lefthand side of (6.15) containing $\nabla_{x} \mathbf{u}$ are strong enough to control the velocity terms on the right-hand side.

### 7.1. Viscosity

In accordance with hypotheses (2.1) and (2.2) we have

=\kappa_{2}\left[\tilde{\theta}\left|\nabla_{x} \theta-\nabla_{x} \tilde{\theta}\right|^{2}-(\theta-\tilde{\theta}) \partial_{y} \tilde{\theta} \partial_{y}(\theta-\tilde{\theta})\right] \tag{7.9}
\end{gather*}
$$

Finally,

$$
\begin{gather*}
\kappa_{3} \theta \tilde{\theta}\left|\nabla_{x} \theta\right|^{2}-\kappa_{3} \theta^{2} \partial_{y} \theta \partial_{y} \tilde{\theta}+\kappa_{3}(\theta-\tilde{\theta}) \tilde{\theta}\left|\partial_{y} \tilde{\theta}\right|^{2}+\kappa_{3} \tilde{\theta}^{2} \partial_{y} \tilde{\theta} \partial_{y}(\tilde{\theta}-\theta) \\
=\kappa_{3}\left[\tilde{\theta} \theta \nabla_{x} \theta \cdot\left(\nabla_{x} \theta-\nabla_{x} \tilde{\theta}\right)+\tilde{\theta} \theta \partial_{y} \theta \partial_{y} \tilde{\theta}-\theta^{2} \partial_{y} \theta \partial_{y} \tilde{\theta}+(\theta-\tilde{\theta}) \tilde{\theta}\left|\partial_{y} \tilde{\theta}\right|^{2}+\tilde{\theta}^{2} \partial_{y} \tilde{\theta} \partial_{y}(\tilde{\theta}-\theta)\right] \\
=\kappa_{3}\left[\tilde{\theta} \theta\left|\nabla_{x} \theta-\nabla_{x} \tilde{\theta}\right|^{2}+2 \tilde{\theta} \theta \partial_{y} \theta \partial_{y} \tilde{\theta}-\theta^{2} \partial_{y} \theta \partial_{y} \tilde{\theta}-\tilde{\theta}^{2} \partial_{y} \tilde{\theta} \partial_{y} \theta\right] \\
=\kappa_{3} \tilde{\theta} \theta\left|\nabla_{x} \theta-\nabla_{x} \tilde{\theta}\right|^{2}-\kappa_{3}(\theta-\tilde{\theta})^{2} \partial_{y} \theta \partial_{y} \tilde{\theta} \tag{7.10}
\end{gather*}
$$

where

$$
\kappa_{3}(\theta-\tilde{\theta})^{2} \partial_{y} \theta \partial_{y} \tilde{\theta}=\kappa_{3}\left|\partial_{y} \tilde{\theta}\right|^{2}(\theta-\tilde{\theta})^{2}+\kappa_{3} \partial_{y}(\theta-\tilde{\theta}) \partial_{y} \tilde{\theta}(\theta-\tilde{\theta})^{2}
$$

We conclude by observing that the terms on the right-hand side of (7.8)(7.10) have either "good" sign or they can be "absorbed" by the remaining integrals in (7.7). Therefore, using (7.8)-(7.10) we can rewrite the inequality (7.7) in the form ${ }^{1}$

\begin{gathered}
\frac{1}{\left|Q_{\varepsilon}\right|} \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho\left|\mathbf{u}_{\varepsilon}-\tilde{\mathbf{u}}\right|^{2}+\mathcal{E}\left(\rho_{\varepsilon}, \theta_{\varepsilon} \mid \tilde{\rho}, \tilde{\theta}\right)\right)(\tau, \cdot) d x \\
\leq \Gamma(\varepsilon)+c \frac{1}{\left|Q_{\varepsilon}\right|} \int_{0}^{\tau} \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho\left|u_{\varepsilon}^{3}-\tilde{u}\right|^{2}+\mathcal{E}\left(\rho_{\varepsilon}, \theta_{\varepsilon} \mid \tilde{\rho}, \tilde{\theta}\right)\right) d x d t
\end{gathered}
$$

for almost all $\tau \in[0, T]$ with $\Gamma(\varepsilon) \rightarrow 0$ as $\varepsilon \rightarrow 0$.
The Gronwall inequality yields

$$
\frac{1}{\left|Q_{\varepsilon}\right|} \int_{\Omega_{\varepsilon}}\left(\frac{1}{2} \rho\left|\mathbf{u}_{\varepsilon}-\tilde{\mathbf{u}}\right|^{2}+\mathcal{E}\left(\rho_{\varepsilon}, \theta_{\varepsilon} \mid \tilde{\rho}, \tilde{\theta}\right)\right)(\tau, \cdot) d x \leq \Gamma(\varepsilon, T)
$$

where $\Gamma(\varepsilon, T) \rightarrow 0$ as $\varepsilon \rightarrow 0$. Consequently, the main theorem is proven.
